BYLAW # 02-20

A BYLAW OF THE VILLAGE OF MEACHAM TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED FOR THE USE OF SEWER.

The Council of the Village of Meacham of the Province of Saskatchewan enacts as follows:

1. This bylaw shall be cited as “The Water and Sewer Rates Bylaw.”
2. In this bylaw, including this section;
 - (a) “Municipality” means the Village of Meacham.
 - (b) “Administrator” means the Administrator of the municipality.
3. The water charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule “A” attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
4. The owner of a building or property is responsible for the connection, disconnection and payment of water and sewage utilities for their property.
5. Accounts for water and sewer service shall cover a period of three successive months, and shall be rendered on or before the tenth day of the month following such periods.
6. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule “B” attached.
7. The penalty on all water and sewer accounts that are unpaid after 30 days shall be 2% of the arrears or the combined amount, as the case may be, per month.
8. If an account is not paid within 30 days the water service shall be cut off. When water is so cut off, it shall not be resumed until all arrears have been paid, together with a reconnection fee of \$100.00, if the reconnection to reinstate the said service is requested. If the reconnection needs to be done after regular business hours the rate will be \$200.00. After hour reconnection will depend on the discretion and availability of the municipality
9. Any person who contravenes any provision of this bylaw for which no other penalty is provided shall be guilty of an offence and liable upon conviction to penalties set forth by the council of the municipality.
11. Bylaw No. 03-18 is hereby repealed.

The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Saskatchewan Municipal Board, Local Government Committee.

Schedules to Bylaw No 2-20 SCHEDULE "A"

As per section 3 of this bylaw, the following units are to be charged at 4000 gallons for 3 months at a rate of \$150.00.

If the water is connected less than three months during any one billing period a rate of \$50 per 1,333 gallons per month.

At no time will the bill be prorated for less than one month.

The following shall pay for the service as listed above:

- single family dwelling
- financial institutions
- restaurants
- churches
- stores
- elevators
- unclassified (not named within)

Water used in excess of 4000 gallons/three months will be charged a rate of \$ 15.00 per 1000 gallons.

SCHEDULE "B"

Persons who own premises drained or required to be drained into the sewer, as per section 6, shall pay for such services during a three-month period in accordance with the following:

Restaurants/Hotels	All Others
\$140.00	\$120.00

In Addition to the above rates, a monthly Levy of \$15 per connected property will be charged for the WTP Upgrade and end on December 31, 2023.
